#### A - News in focus





New decision amending some policies to support employees and employers facing difficulties due to the COVID-19 pandemic

(Taking effect from 06 Nov 2021)

On November 6, 2021, the Prime Minister enacted Decision 33/2021/QD-TTg amending and supplementing a number of Articles of Decision 23/2021/QD-TTg dated 07 July 2021 of the Prime Minister stipulating the implementation of several policies to support employees and employers facing difficulties due to the COVID-19 (hereinafter referred to as "Decision 33/2021/QD-TTg"), which takes effect on the same day.

In this legal update, we reveal the most highlights of Decision 33/2021/QĐ-TTg.



# 1. Supporting employees and employers who temporarily suspend to contribute to the Retirement and Pension Fund
