



A – News in focus



New regulations on adjustment of pension, social insurance allowance and monthly allowance

(Implemented from 01 Jan 2022)

On 06 Dec 2021, the Government enacted Decree 108/2021/ND-CP on the adjustment of pension, social insurance allowance and monthly allowance *(hereinafter referred to as "Decree 108/2021/ND-CP")*, which takes effect from 20 Jan 2022, the regulations under this Decree will be implemented from 01 Jan 2022.

In this legal update, we reveal the most highlights of Decree No. 108/2021/ND-CP.

Adjustment time:

From 01 Jan 2022

Subjects to be adjusted: Persons receiving pensions, social insurance benefits and monthly allowances before January 1, 2022, including:



Cadres, civil servants, workers, officials, employees including those paying voluntary social insurance, retiring from Nghe An farmer's social insurance fund to switch to.



Soldiers participating in the resistance war against the US have less than 20 years working in the army, have served or been discharged, and are receiving monthly allowance.



Policemen participating in the resistance war against the US have less than 20 years working in the police, have quit their jobs, been discharged, and are receiving a monthly allowance.

Soldiers, policemen, people doing cipher work receive salaries like soldiers; Policemen who participated in the war and performed international duties after April 30, 1975, have served, been discharged from the army, quit their jobs, and received monthly allowances.



Soldiers, policemen, and people doing cipher work are receiving monthly pensions.



Commune, ward and township officials; Commune, ward and township officials are receiving monthly allowances.



People who are receiving monthly allowance for loss of working capacity.



Rubber workers are receiving monthly allowance.

General adjustment level:

Increase 7.4% on pension, social insurance allowance and monthly allowance of December 2021 of individuals under subjects to be adjusted.

Specific adjustment level:

Individuals under subjects to be adjusted:

- Retired before 01 Jan 1995; and
- After being adjusted to increase according to the general level, the pension, social insurance allowance and monthly allowance:

2.300.000 - < 2.500.000 dong/person/month

Increase to 2.500.000 dong/person/month

≤ 2.300.000 dong/person/month ←

Increase 200.000 dong/person/month
