


# New Legal documents

#### A - News in focus



Sanction of administrative violations in the field of labor, social insurance,
Vietnamese employees
working abroad under contracts

(Taking effect from 17 January 2022)

On 17 January 2022, the Government enacted Decree 12/2022/ND-CP stipulating on the sanction of administrative violations in the field of labor, social insurance, Vietnamese employees working abroad under contracts (hereinafter referred to as "Decree 12/2022/ND-CP"), which takes effect on the same date.

In this legal update, we reveal some highlights of Decree 12/2022/ND-CP.



#### Type of sanction

- Warning or fine.
- Deprivation of the right to use the labor outsourcing license for a term of between 06 and 12 months.
- Confiscation of exhibits on the administrative violations: Fake licenses, certificates.
- Suspend related activities from 1 to 24 months depending on each specific cases.

#### **Fines**

VND 1 - 3 million



Do not notify in writing when terminating the labor contract



Do not close social insurance books and employees

VND 5 - 10 million



Do not publicize the salary scale and table, bonus rules

VND 15 – 30 million



Sexual harassment at workplace

Do not allow female employees to take a break of 30 minutes/day during menstruation VND 10 - 20 million

Do not install milking room when there are more than 1000 female employees

Falsify dossiers to seek profit from insurance

VND 20 – 40 million



Monetary fine, salary cut instead of labor discipline



Discipline employees who are on sick leave and are temporary detained...

VND 50 – 75 million



Force employees to perform labor contract to pay debts



Abuse, harassment... domestic helpers
