The usual 5-step process of appointing contractors

(Applied from 08 August 2022)

On August 08, 2022, the Minister of Planning and Investment just issued Official dispatch No. 5520/BKHDT-QLDT guiding the implementation of the specific mechanism on contractor appointment according to the Resolutions of the National Assembly *(hereinafter referred to as "Official dispatch 5520/BKHDT-QLDT")*.

In this legal update, we reveal the usual 5-step process of appointment of contractors according to the instructions in Official dispatch 5520/BKHDT-QLDT.



The usual 5-step process of appointing contractors

Step 1: Preparing for contractor selection

- The bid solicitor prepares a request for proposals.
- Appraisal organization conducts an appraisal of request documents (maximum 20 working days).
- Investor approves required documents (maximum 20 working days).

Step 2: Organizing contractor selection

- The bid solicitor issues the dossier of requirements to the identified contractor.
- The contractor prepares and submits proposals (minimum 5 working days).

Step 3: Evaluate proposals

- Expert team to evaluate proposals (maximum 30 working days).
- The bid solicitor and the contractor negotiate on the contractor's proposals.



Step 4: Submitting to appraise, approve and publicize contractor appointment results

- The bid solicitor submits the approval of the contractor appointment result.
- Appraisal organization conducts an appraisal of contractor appointment results (maximum 20 working days).
- Investor approves contractor appointment result (maximum 10 working days).
- Inviting bids publically contractor appointment results (maximum 07 working days).

Step 5: Finalizing and signing the contract

The contract signed between the parties must be consistent with the decision approving the contractor appointment result, the contract negotiation records, the proposal, the request, and other relevant documents.



In Official dispatch 5520/BKHDT-QLDT, the Ministry of Planning and Investment stated that this contractor appointment procedure must be completed before December 31, 2023.
