Insurance allowances after the base salary increases

(Taking effect from 01 July 2023)

On 11 November 2022, the National Assembly voted to approve the **Resolution on State Budget Estimate** in 2023 with nearly 91% of the delegates in favor.

Accordingly, the National Assembly agreed to increase the base salary for civil servants and public employees to *VND 1,800,000/month* from *July 1, 2023*, which is an increase of 20.8% compared to the current base salary (VND 1,490,000/month from 1 July 2019 according to Decree 38/2019/ND-CP).

With the increase in base salary from July 1, 2023, non-state employees also receive more social insurance benefits from July 1, 2023.

Convalescence allowance after being sick

The allowance for convalescence and health rehabilitation after being sick for one day is equal to 30% of the base salary (Clause 3 Article 29 of the Social Insurance Law 2014).



⇒ If the base salary increase to VND 1,800,000 per month, this allowance will also increase:

VND 447,000/day



VND 540,000/day

A lump-sum allowance after maternity

Female employees or employees who adopt children under 6 months old are entitled to a lump-sum allowance for each child equal to 02 times the base salary in the month in which the female employee gives birth or the month in which the employee adopts the child. (Article 38 of the Law on Social Insurance 2014).

⇒ If the base salary increase to VND 1,800,000 per month, this allowance will also increase:

VND 2,980,000/kid



VND 3,600,000/kid



Convalescence allowance after maternity

The allowance for convalescence and health rehabilitation after maternity for one day is equal to 30% of the base salary (Clause 3 Article 41 of the Law on Social Insurance 2014).

⇒ If the base salary increase to VND 1,800,000 per month, this allowance will also increase:

VND 447,000/day



VND 540,000/day

Funeral allowance

When the following people die, the person taking care of the funeral will receive a funeral allowance equal to 10 times the base salary (Article 66 of the Law on Social Insurance 2014):

- Employees who are paying social insurance premiums or who have reserved their time of paying social insurance premiums and have paid social insurance premiums for at least 12 months;
- Employees die because of occupational accidents or diseases or die during treatment due to occupational accidents and diseases;
- Persons are on pension; receive monthly occupational accident and disease allowance and have quit work.
- ⇒ If the base salary increase to VND 1,800,000 per month, this allowance will also increase:

VND 14,900,000



VND 18,000,000

Monthly survivor allowance

Monthly survivor allowance for each person specified in Article 68 of the Law on Social Insurance 2014:

• In case there is no person to directly take care of, the monthly survivor allowance is equal to 70% of the base salary:

VND 1,043,000/day



VND 1,260,000/day

• Towards other cases, the monthly survivor allowance is equal to 70% of the base salary:

VND 745,000/day



VND 900,000/day
