

A - News in focus



New Decree guiding the Law on Tax Administration

(Effective from 30 Oct 2022)

On 30 Oct 2022, the Government enacted Decree 91/2022/ND-CP amending and supplementing several Articles of Decree 126/2020/ND-CP dated 19 Oct 2020 stipulating in detail several Articles of the Law on Tax Administration (hereinafter referred to as "*Decree 91/2022/ND-CP*"), which takes effect from the same day.

In this legal update, we reveal some highlights of Decree 91/2022/ND-CP.

Decree 91/2022/ND-CP

Decree 126/2020/ND-CP

1. Regulation on the last day for tax payment and tax returns submission

If the last day of the deadline for submitting tax returns and the deadline for tax payment falls on a holiday, the last day of the deadline for filing tax returns and the tax payment deadline will be determined to be the next business day subsequent to the holiday.

No regulation.

2. Cases that the taxpayer is not required to submit a tax return

Supplement 01 case in comparison with regulations in Decree 126/2020/ND-CP:

Personal income tax declarant is an organization or individual paying income in the case of monthly or quarterly personal income tax declaration but in that month or quarter there is no deduction of personal income tax of the recipients of income. 05 cases in accordance with Clause 3 Article 7 of Decree 126/2020/ND-CP.

3. Regulation on the ratio of total corporate income tax to be temporarily paid

The total amount of CIT temporarily paid for 4 quarters must not be less than 80% of the payable CIT amount according to the annual finalization.

The total temporarily paid CIT amount of the first 3 quarters of the tax year must not be lower than 75% of the payable CIT amount according to the annual finalization.

4. Regulation on the remaining after-tax profit after setting up funds of enterprises in which 100% of charter capital is held by the State

The total remaining after-tax profit after provisioning temporarily paid funds of 04 quarters must not be less than 80% of the remaining after-tax profit after provisioning funds according to the annual finalization.

The total remaining after-tax profit after provisioning temporarily paid funds of the first 03 quarters of a tax year must not be less than 75% of the remaining after-tax profit after provisioning funds according to the annual finalization.

5. Replace the form of notice to stop using invoice

6. Form using for the request of adjustment to reduce late payment
