Summary of the new provisions of several notable laws and by-law documents concerning tax- fees that take effect on February 2023



Remarkable among documents:

Decree 02/2023/ND-CP details the implementation of a number of articles of the Law on Water Resources.

A – News in focus



New prominent tax policies are updated in new legal documents taking effective on February 2023, which guide the implementation of a number of current tax documents.

In this legal update, we summarize the new points and the basic substance of the regulations that were issued and will come into full force in February and March 2023.

Raw materials, supplies, and components will be tax-exempted to directly develop the information technology.

Circular 25/2022/TT-BTTTT takes effective on February 15, 2023, and set forth the determination of raw materials, supplies, and components directly serving the production of technology, information, digital content, and software exempt from import tax. Specifically:

- Authorization: The Minister of Information and Communications sets forth the determination of raw materials, supplies, and components directly serving the production of technology, information, digital content, and software exempt from import tax.
- Raw materials, supplies, and components must meet the following criteria:
 - belonging to the list of software, hardware, and electronic products specified in Circulars 09/2013/TT-BTTTT and 20/2021/TT-BTTT, or on the list of digital products prescribed by the Ministry of Information and Communications.
 - Không thuộc Danh mục máy móc, thiết bị, nguyên liệu, vật tư, linh kiện ngành viễn thông công nghệ thông tin, nội dung số, phần mềm trong nước đã sản xuất được tại phụ lục 8 ban hành kèm theo Thông tư 05/2021/TT-BKHĐT.

Fees for the evaluation of environmental rehabilitation and restoration

Circular 07/2023/TT-BTC takes effect on March 20, 2023, and replaces Circular 35/2017/TT-BTC dated April 25, 2017. Accordingly, the fee for the appraisal of the plan for environmental renovation and restoration supported by the central agency is expected to:

- If the total investment capital of the project is up to 10 billion VND: 6 million VND;
- If the total investment capital of the project is more than 10 20 billion VND: 9 million VND;
- If the total investment capital of the project is more than 20 50 billion VND: 15 million VND;
- If the total investment capital of the project is more than 50-100 billion VND: 27 million VND ;
- If the total investment capital of the project is more than 100 200 billion VND: 30 million VND;
- If the total investment capital of the project is more than 200 500 billion VND: 39 million VND;
- If the total investment capital of the project is more than 500 1000 billion VND: 44 million VND;
- If the total investment capital of the project is more than 1000 1500 billion VND: 48 million VND;
- If the total investment capital of the project is more than 1500-2000 billion VND: 49 million VND;
- If the total investment capital of the project is more than 2000-3000 billion VND: 51 million VND;
- If the total investment capital of the project is more than 3000-5000 billion VND: 53 million VND;
- If the total investment capital of the project is more than 5000-7000 billion VND: 56 million VND;
- If the total investment capital of the project is more than 7000 billion VND: 61 million VND.

Land rent reduction for subjects affected by COVID-19

Decision 01/2023/QD-TTg dated January 30, 2023 on the reduction of land rent and water surface rent in 2022 for subjects affected by the Covid-19 epidemic.

- Subjects eligible for land rent reductions include:
- directly as a result of decision;
- contract or certificate of land use rights, ownership of houses and other land-attached assets
- Fee reduction for land use:

Reduce the land rent and water surface rent payment in 2022 by 30%. However, no reduction will be made in outstanding land and water surface rents from prior years, or in late payment interest (if any).
