# Competence to issue a Certificate of land use rights from May 20, 2023

From May 20, 2023, Decree 10/2023/ND-CP amending and supplementing several Articles of Decrees guiding the implementation of the Law on land takes effect.

Accordingly, for localities that have established land registration offices prescribed in Clause 1 Article 5 of Decree 43/2014/ND-CP, the issuance of certificates and confirmation of changes to the issued certificates shall be as follows:

- Land registration offices for religious organizations and establishments; overseas
  Vietnamese implementing investment projects; foreign organizations and individuals; foreign-invested enterprises;
- Branches of land registration offices or land registration offices shall apply to households, individuals, residential communities, overseas Vietnamese who are entitled to own houses attached to residential land use rights in Vietnam;
- The Land Registration Office, Branch of the Land Registration Office may use its seal to carry out the issuance of the Certificate, certifying the change to the issued Certificate.

For localities that have not yet established land registration offices as prescribed in Clause 1, Article 5 of Decree 43/2014/ND-CP:

- The Department of Natural Resources and Environment shall grant certificates to religious organizations and establishments; overseas Vietnamese implementing investment projects; foreign organizations and individuals; foreign-invested enterprises;
- The district-level People's Committee shall issue certificates to households, individuals, residential communities, overseas Vietnamese to own houses attached to residential land use rights in Vietnam.

In case the provincial People's Committee authorizes the Department of Natural Resources and Environment to issue certificates of land use rights, ownership of houses and other assets attached to land specified in Clause 1, Article 105 of the Law on Land 2013, the seal of the Department of Natural Resources and Environment may be used .

The Ministry of Natural Resources and Environment shall regulate cases of issuance of certificates of land use rights, ownership of houses and other assets attached to land when registering land fluctuations and land-attached assets and the confirmation of changes in granted certificates.

# Time of calculating land rent collection when extending or adjusting the term of land use

From May 20, 2023, Decree 10/2023/ND-CP amending and supplementing several Articles of Decrees guiding the implementation of the Law on land takes effect.

Accordingly, the new Decree supplementing Article 18a of Decree 44/2014/ND-CP on the time of calculating land rent collection in case of land use extension or adjustment of land use term, as follows:

- In case a land user is granted a land use extension by a competent state agency upon expiry of the use term, the time of calculating land rent collection shall be the first day of the next land lease term.
- In case a land user is decided by a competent state agency to adjust the land use term:
- In case the use of land originating from land leased by the State collects land rent once for the whole lease period, the time of calculating land rent collection is the time when the State decides to adjust the land use term. The collection, deduction and refund of land rent shall comply with the provisions of the law on land rent collection;
- In case land use originates from land leased by the State to collect annual land rent, the time of calculating land rent collection for the first land rental unit stabilization cycle is the time when the State decides to adjust the land use term to calculate annual land rent collection.

In addition, in case of application of land valuation methods in Article 4 of Decree 44/2014/ND-CP: The provincial People's Committee shall issue a decision approving specific land prices within 90 days from the date on which a competent state agency issues a decision on land allocation, leasing land, changing land use purposes, allowing to change from land lease paying annual land rent to land lease paying land rent once for the whole lease period, land use extension, adjustment of land use term.
