

SOME OUTSTDANDINGS UPDATE ON ENTRY, EXIT AND RESIDENCE IN VIETNAM OF VIETNAMESE CITIZEN EXPORTS AND FOREIGNERS



Citizens and the Law on Entry, Exit, Transit, and Residence for Foreign Citizens in Vietnam came into effect with new updates. Some noteworthy changes include:

1. Add the place of birth to the passport

The official information regarding immigration documents (passports) will encompass the following details:

- Portrait:
- Full name;
- Gender:
- Place of birth;
- Date of birth;
- Nationality;
- Sign, entry and exit paper numbers, granting agency, and expiration dates (including month and year)
- Personal identification numbers or identity card numbers;
- Diplomatic and official passports may include positions and titles relevant to foreign affairs.ai;
- Other information

2. Visa extension and visa exemption period

- Electronic visa (EV) can now be extended for up to 90 days and can be used once or multiple times. For visas with a duration of less than 1 year, the visa duration will be calculated in days to ensure consistency
- Citizens of countries that are unilaterally exempted from visas by Vietnam will be allowed to stay temporarily for up to 45 days.

3. Citizens who do not receive passports will have their passport validity canceled.

Passports not received within 12 months of scheduled appointment will be cancelled if no reason for delay is given.

CONDITIONS FOR FOREIGN LOAN NOT GUARANTEED BY THE GOVERNMENT



Starting from May 18, 2023, Circular 08/2023/TT-NHNN sets out the conditions for foreign loans not be guaranteed by the Government.

- ➤ Borrowing currency is a foreign currency, there are 03 cases where foreign loans are allowed in Vietnam dong, adding one case than before, as follows:
- a) The borrower in question is a microfinance institution;
- b) A foreign direct investment company is borrowing profits from their direct investment activities in Vietnam. The lender is a foreign investor who has contributed capital to the borrower;
- c) The borrower takes out funds and pays back the debt in a foreign currency, but the loan obligation is determined in VND
- > Specific subjects are subject to limit on short-term foreign loans:
- a) Commercial banks are required to pay 30% of the total principal balance for short-term foreign loans.
- b) Foreign banks or other credit institution must maintain 150% of their short-term foreign loan amount.
- c) For those who are not credit institutions, foreign bank branches can be a viable option:
- Foreign loans for investment projects must meet certain conditions. The borrower's total loans, including short-term loans, cannot exceed the project's borrowing limit. This limit is determined by subtracting the investor's contributed capital from the total investment capital.
- When a borrower applies for foreign loans to fund their production, business or other projects, their medium and long-term domestic and foreign loan balance (including short-term loans) that are overdue or extended should not exceed the total loan demand specified in the Plan for using foreign loans approved by the competent authority.
- New foreign loans for debt restructuring cannot exceed the existing debt's principal balance, interest, and fees. The amount of new loans is determined during restructuring.

AMENDING AND SUPPLEMENTING SOME PROVISIONS ON LICENSE ISSUANCE, ORGANIZATION AND OPERATION OF NON-BANK CREDIT INSTITUTIONS

Circular 05/2023/TT-NHNN has been issued by the State Bank, to amend and supplement certain articles of Circular No. 30/2015/TT-NHNN. This relates to the licensing, organization, and operation of credit institutions (including non-bank credit institutions) and will take effect from August 6, 2023.

1. The process and guidelines for authorizing operational licenses for non-banking credit institutions

The State Bank now has a shorter time frame to send a confirmation to the Preparatory Board stating that they have received all necessary and valid documents for consideration and approval in principle. If any additional documents are needed, they must be requested promptly.

2. Modifying and enhancing the process of submitting the charter to the State Bank

Non-banking credit institutions must send their approved Charter to the State Bank within 15 days of approval. Any changes or additions to the Charter must also be sent within 15 days of approval.



ADDITIONAL SECURITY AND ORDER CONDITIONS APPLY TO CERTAIN CONDITIONAL BUSINESS LINES

On August 15, 2023, the government will implement Decree 56/2023/ND-CP, which modifies Decree 96/2016/ND-CP regarding the security and order requirements for certain business sectors. Additionally, Decree 99/2016/ND-CP concerning the management and use of seals and Decree 137/2020/ND-CP regarding the management and use of firecrackers will also be in effect.

1. Enhancing the safety and organizational standards of pawn establishments.

Pawnshop security personnel are exempt from penalties for certain actions in the five years before registering the business, including resisting official duties and organizing or participating in gambling activities.

2. Enhancing the accuracy and structure of the application process for obtaining the Certificate of Satisfaction of Security and Order Conditions.

To ensure security and order, any business must obtain a Certificate of Satisfaction. This certificate can be obtained either as a physical or electronic document, both with the same legal validity. Businesses can submit their application in three ways: directly to the competent police agency, through the public postal service, or through the National Public Service Portal or the Public Service Portal of the Ministry of Public Security (excluding any documents that are prohibited from being posted online by law).

3. Regulate export/import of fireworks and explosives:

- Use the form in Appendix VI of this Decree to request, including the organization or enterprise's name and address under the Ministry of National Defense;
- Submit a written request through the National Public Service or Ministry of Public Security portal or send a letter to the Police Department. If an organization or enterprise submits the request directly to the Police Department, the written request for addition of full name, number of citizen identification, identity card or passport;
- The Police Department and Ministry of Public Security will issue an import/export license within 3 days of receiving a written request using Appendix I form. If refused, a clear reason must be given in writing;
- The validity period for the import and export license is 60 days.
