03 cases of choosing to withdraw social insurance 01 time or enjoy pension from 01/7/2025



Remarkable among documents:

Decree 132/2024/ND-CP regulating outward investment in oil and gas activities

A - News in focus



Withdrawing social insurance 01 time will lose the opportunity to receive monthly pension and health insurance at the end of working age. The Law on Social Insurance 2024 clearly stipulates the cases of choosing to withdraw social insurance 1 time or enjoy pension.

In this legal update, WIKI LEGAL will detail these cases as well as new regulations related to this content.

No. 2 – Oct, 2024 WIKI LEGAL LLC

03 cases in which the employee can choose to enjoy a monthly pension or withdraw social insurance 01 time

- (1) Going abroad to settle down
- (2) Suffering from severe diseases such as cancer, polio, cirrhosis, severe tuberculosis, AIDS or a decrease in working capacity from 81%;
- (3) For foreign employees, there are additional cases where the contract expires or the work permit is not renewed.

Specifically, as follows:

1.1. For employees participating in compulsory social insurance

Pursuant to Clause 6, Article 70 of the Law on Social Insurance 2024 (effective from July 1, 2025), employees participating in compulsory social insurance who are both eligible for pension and one-time withdrawal of social insurance may choose to enjoy a monthly pension or one-time social insurance in the following cases:

- a. For Vietnamese employees:
- Going abroad to settle down;
- People who are suffering from one of the following diseases: cancer, polio, decompensated cirrhosis, severe tuberculosis, AIDS;
- Persons with a working capacity decrease from 81%; people with particularly severe disabilities.
- b. For employees who are foreign citizens working in Vietnam and are subject to compulsory social insurance:
- People who are suffering from one of the following diseases: cancer, polio, decompensated cirrhosis, severe tuberculosis, AIDS;
- Persons with a working capacity decrease from 81%; people with particularly severe disabilities;
- An employee who terminates a labor contract or work permit, or their practice certificate or practice license expires without renewing it.

1.2. For employees participating in voluntary social insurance

According to Clause 5, Article 102 of the Law on Social Insurance 2024, employees participating in voluntary social insurance who are both eligible for pension and one-time withdrawal of social insurance are entitled to a monthly pension or one-time social insurance in the following cases:

- Going abroad to settle down;
- People who are suffering from one of the following diseases: cancer, polio, decompensated cirrhosis, severe tuberculosis, AIDS;
- Persons with a working capacity decrease from 81%; people with particularly severe disabilities.

Some new points on one-time withdrawal of social insurance from 01/7/2025

2.1. Change the deadline for receiving one-time social insurance premium

From July 1, 2025, employees will receive social insurance money once within 7 business days after the social insurance agency receives a complete dossier.

(Currently, the time limit for settlement is 10 days)

2.2. Drop the case: Employees who have paid social insurance premiums for less than 20 years after 01 year of leaving from work are entitled to withdraw one-time social insurance

Employees participating in social insurance from July 1, 2025 after 01 year of resignation, not participating in social insurance and having not paid social insurance for full 20 years, are not allowed to withdraw one-time social insurance.

2.3. Subjects are not allowed to withdraw one-time social insurance

- Employees who have paid social insurance premiums for full 20 years or more, except for cases of going abroad to settle down or suffering from one of the lifethreatening diseases;
- Employees participating in social insurance before July 1, 2025 have paid social insurance premiums for less than 20 years but have taken less than 12 months off work. Except for cases of full pension age but less than 15 years of paying social insurance premiums, going abroad to settle down or suffering from one of the life-threatening diseases;
- Employees start participating in social insurance from July 1, 2025, after 01 year
 of quitting their jobs, no longer participating in social insurance but less than 20
 years of paying social insurance. Except for cases of full pension age but less
 than 15 years of paying social insurance premiums, going abroad to settle down
 or suffering from one of the life-threatening diseases;
- Officers, non-commissioned officers, standing militia,..who demobilize, demobilize
 or resign that are eligible for pensions, except for cases of going abroad to settle
 down or suffering from one of the life-threatening diseases.

2.4. The Law on Social Insurance 2024 facilitates employees who have withdrawn one-time social insurance to enjoy pension

Accordingly, employees who reach the retirement age and have paid social insurance from 15 years will be entitled to enjoy a monthly pension, instead of having to pay the full 20 years as before.

This helps people who have withdrawn one-time social insurance or joined the social insurance late (45-47 years old) can still accumulate for 15 years to enjoy pensions.
